SWEEPSTAKES - OFFICIAL RULES**

THE FOLLOWING SWEEPSTAKES IS INTENDED FOR THE UNITED STATES ONLY AND SHALL ONLY BE CONSTRUED ACCORDING TO UNITED STATES LAW.

1. **OBJECT OF THE SWEEPSTAKES:** As provided in these Sweepstakes official rules (“Official Rules”), prizes in the Washington Valor™ BUD LIGHT® “General Manager for a Day”™ Sweepstakes (“Sweepstakes”) will be awarded in a random drawing to a limited number of persons submitting valid entries. If they like, Entrants can also post to the Washington Valor social media site a photograph of themselves alone showing how they support the Washington Valor team, but posting the photograph is not required to enter the Sweepstakes and will not affect their chances of winning.

2. **SPONSORS:** The sponsors of the Sweepstakes are Lincoln Valor LLC dba Washington Valor Arena Football (“Washington Valor”), Lincoln Holdings LLC dba Monumental Sports & Entertainment (“MSE”), and Anheuser-Busch, LLC (“Anheuser-Busch”) (collectively, “Sponsors”). The administrators of the Sweepstakes are Washington Valor and Lincoln Holdings LLC dba Monumental Sports & Entertainment (collectively, “Administrators”).

3. **TERRITORY:** The territory of the Sweepstakes is limited to Washington, D.C. and those parts of the States of Maryland and Virginia in U.S. Postal Service ZIP Codes within seventy-five (75) miles of the Capital One Arena in Washington, D.C. Eligible ZIP Codes are set forth in Appendix attached to the Official Rules. The Sweepstakes is subject to all applicable federal, state and local laws, rules and regulations. Void outside the territory listed above and where prohibited or restricted by law, rule or regulation.

4. **AGREEMENT TO OFFICIAL RULES AND PRIVACY POLICY:** By entering the Sweepstakes, entrants agree to be bound by the Official Rules available at <http://info.monumentalsports.com/LP=2186> (“Official Rules”) and the current Monumental Sports Network Privacy Policy (September 15, 2016) available at <https://www.monumentalsportsnetwork.com/privacy-policy> (“MSN Privacy Policy”). Personal data, including without limitation your name, date of birth, postal address, telephone number, and e-mail address (“Personal Information”) submitted with an Entry (as defined below) or otherwise disclosed to Administrators in connection with the Sweepstakes may be collected, used, and disclosed by Administrators to conduct and promote the Sweepstakes and as otherwise provided by the MSN Privacy Policy.

5. **ELIGIBILITY:** The Sweepstakes is open only to persons twenty-one (21) years of age or older who reside in Washington, D.C. or parts of the states of Maryland or Virginia in U.S. Postal Service ZIP Codes within seventy-five (75) miles of the Capital One Arena, located at 601 F Street, NW, Washington, DC 20004. Eligible ZIP Codes are set forth in the Appendix attached to the Official Rules. Employees, directors, officers, and partners of Anheuser-Busch LLC, Lincoln Valor LLC, Lincoln Holdings LLC dba Monumental Sports & Entertainment, Capital One, Arena Football League, or their respective affiliates and subsidiaries, distributors, retailers, licensees, and advertising and promotional agencies, and the immediate families or households of any such employee, director, officer, or partner, whether or not related, are ineligible for the Sweepstakes. Affiliated companies of Lincoln Valor LLC and Lincoln Holdings LLC dba Monumental Sports & Entertainment include Lincoln GP LLC, Anacostia Sports LLC, Washington Sports & Entertainment LP, Washington Sports & Entertainment Inc., Washington Sports LLC, Washington Sports GP LLC, DC Arena LP dba Capital One Arena, AP Tickets Inc., Centre Group LP, Monumental Ticketing LP, Lincoln Hockey LLC, Lincoln Mystics LLC dba Washington Mystics, Lincoln Ballston LLC, and Lincoln Ventures LLC. Entrants must present proof of eligibility and satisfy other conditions provided in the Official Rules to be awarded a Prize.

6. **SWEEPSTAKES PERIOD:** The Sweepstakes begins at 12:00:00 a.m. Eastern Time (“ET”) on May 10, 2019 and ends upon determination of the winners, which is scheduled for approximately May 31, 2019 (“Sweepstakes Period”).

8. **HOW TO ENTER:** To enter the Sweepstakes, (i) visit the official Washington Valor™ BUD LIGHT® “General Manager for a Day”™ web site at <http://info.monumentalsports.com/LP=2186> (“Sweepstakes Web Site”) (Facebook or Twitter users will be directed to the Sweepstakes Web Site), (ii) read and agree to the Official Rules and MSN Privacy Policy, (iii) complete the entry form by providing your full name, date of birth, ZIP Code, telephone number, and e-mail address, (iv) confirm that you are at least twenty-one (21) years old, and (v) submit the entry by clicking “Submit” (an “Entry” or “Entries”).

Entries that are not received during the Entry Period, do not include an eligible ZIP Code or a valid e-mail address, omit any information required in the online entry form, name more than one individual, fail to click the checkbox agreeing to these Official Rules and MSN Privacy Policy, or do not comply with the Official Rules will be void.

You may enter as many times as you like. Multiple Entries made using any robotic, macro, automatic, programmed or like entry methods will be void.

Online entry as set forth in these Official Rules is the only method of entering the Sweepstakes. No other forms of entry are valid. You must provide your own computer, mobile device, software, and Internet or mobile connection to enter. You may be asked to consent to receiving commercial e-mails or mobile text messages and updates from one or more of the Sponsors and their respective affiliates, but neither your eligibility for the Sweepstakes or chance of winning a Prize will be affected by whether or not you consent. A Fan Selfie will not be accepted for posting on and/or will be deleted from the Washington Valor social media site if, as determined by the Administrators in their sole discretion, the Fan Selfie contains any material, including words, symbols, or illustrations, expressing or depicting any of the following: (i) profanity, vulgarity, lewdness, nudity, pornography, sexual explicitness or suggestiveness; (ii) violence, criminal or illegal activities, gang colors or insignia, or weapons including but not limited to firearms, knives, projectiles, and explosives or use of such weapons; (iii) bigotry, racism, hatred, or harm against any group or individual, or discrimination based on race, sex, religion, nationality, disability, sexual orientation, age, or any other basis protected by federal, state, or local law, ordinance, or regulation; (iv) excessive, irresponsible, or illegal use of alcohol, tobacco, marijuana, drugs, or controlled substances or use thereof; (v) any activities that may appear unsafe or dangerous; (vi) any particular political agenda or message; (vii) the name or likeness of any person, living or dead, other than Entrant or any personal information or identification thereof such as license plate numbers, personal names, e-mail addresses or street addresses; (viii) trademarks or material protected by copyright or other intellectual property (including but not limited to words, music, photographs, or designs) of any third party; (ix) materials embodying the names, likenesses or other indicia identifying any person, living or dead, other than Entrant; (x) materials prone to misrepresent or deceive; (xi) material prone to misrepresent, libel, slander, defame, slander, disparage, or denigrate any individual, group, or business, including without limitation any Sponsor, Arena

Football League, any Arena Football League team, or the game of indoor football; or (xii) material that is unlawful or otherwise in violation of or contrary to any applicable federal, state, or local law, regulations, or ordinance.

10. **NO OTHER OBLIGATION:** By submitting an Entry, Entrant agrees that his/her Entry is gratuitous and made without restriction and will not place any Sponsor under any obligation other than as stated in these Official Rules,

11. **WINNING A PRIZE:** For the Sweepstakes, the Administrators will conduct a random drawing in which three (3) eligible Entries will be selected as Winners.

The random drawing will be conducted by Administrators.

Your chances of winning a Prize will vary with the number of valid Entries made in the Sweepstakes.

Non-winning Entries will not be carried forward to subsequent Entry Periods or subsequent Sweepstakes. The decisions of the Administrators are final in all aspects of the Sweepstakes.

12. **PRIZES:** Each Winner will win a prize comprising four (4) tickets for seats in the Anheuser-Busch Loge Box and four (4) passes to the Bud Light Party Zone at the Capital One Arena in Washington, D.C. at one (1) Washington Valor regular season home game chosen by Administrators subject to the limitations, terms, and conditions set forth below ("Prize"). Each Winner (but not his/her guests) will also have the opportunity to visit the Washington Valor locker room immediately before and after the game, and wear a coaching headset and sit with the Washington Valor coaches on the field during the first half of the game. Winner will not be entitled to act as a coach for Washington Valor in any way whatsoever, including without limitation determining personnel, calling plays, or calling time-outs. A Prize shall be for only one of the dates set forth in the following table ("Prize Date"), to be determined in the sole discretion of Administrators:

- a. **Number and Value of Prizes:** A total of three (3) Prizes are available for award in this Sweepstakes. Each Prize has an Approximate Retail Value (ARV) of Two Hundred Ninety-Six U.S. Dollars (\$296.00). The total Approximate Retail Value (ARV) of all Prizes available for award in this Sweepstakes is Eight Hundred Eighty-Eight U.S. Dollars (\$888.00).
- b. **Prize Limitations: Limit one (1) Prize per person, family or household during the Sweepstakes Period.** Ticket dates and all prize details will be determined in the sole and absolute discretion of Administrators. Any costs and expenses associated with accepting and using a Prize that are not specified herein as being provided, including but not limited to food, beverage, lodging, transportation costs, and gratuities, are the sole responsibility of the Winner. Complimentary food and beverage included in any Prize is limited to Winner and no more than three guests during normal operating hours of the Bud Light Party Zone and is only for consumption at the Capital One Arena during the game. Administrators, the Bud Light Party Zone, and DC Arena LP reserve the right to refuse to serve any customers, including any Winner and guests, who appear to be intoxicated or otherwise behave in a disruptive manner.
- c. **Ticket and Pass Terms and Conditions:** Tickets and passes awarded as prizes are subject to the terms and conditions set forth on the tickets and passes, and may not be transferred, resold or offered for resale. Any such transfer or resale may result in disqualification and prize forfeiture. Winner and his/her guest(s) agree to comply with all applicable arena regulations in connection with the Prize. Administrators and DC Arena LP reserve the right to remove or to deny entry to Capital One Arena to Winner and/or his/her guest(s) who behave in a non-sportsmanlike, disruptive, or intoxicated manner, or with intent to annoy, abuse, threaten or harass any other person at the game, event or exhibition.

- d. **Prize Substitutions:** Winners may not assign or transfer a Prize, and are not entitled to a substitute prize if unable to use the awarded Prize. Sponsor reserves the right to substitute any prize (or a component thereof) with a prize of equal or greater value for any reason. Furthermore, in the event the Washington Valor football game is cancelled or the Anheuser-Busch Loge Box is closed on any Prize Date, Administrators reserve the right to substitute the same number of tickets for another Washington Valor regular season home game selected at Administrators' discretion, in which case ticket location will depend on availability and be in the sole discretion of Administrators.
- e. **Prizes Not Awarded:** Because there may be an insufficient number of valid Entries, or Potential Winners may be disqualified or fail to claim Prizes, Sponsor retains the right not to award all or any of the available prizes.
- f. **Minimum Age:** As a condition of receiving a Prize, Winners and all of his/her guests must each present Administrators with proof that they are 21 years of age or older.
- g. **Publicity:** Sponsors may but shall not be obligated to publicize a Winner's Entry and/or Fan Selfie, or to interview, photograph, and record, video, and/or film a Winner and his/her guests at the Capital One Arena, and to show such live or recorded interviews, photographs, and record, video, and/or films at the Capital One Arena, on the Sweepstakes Web Site, Sponsors' web sites and social media sites, and at such other places, formats, and times as Sponsors may determine in their sole discretion. A Potential Winner must respond to Administrators as directed in the notification and indicate whether he/she will accept the Prize as offered no later than forty-eight (48) hours after Administrator sends notification. If no response is received by Administrators within the time allotted for any reason, the Potential Winner will be disqualified and forfeit the Prize, and Administrators may in their sole discretion and if time permits select and notify an alternate Potential Winner from among the remaining eligible Entries. Sponsors are not responsible for suspended or discontinued Internet or wireless phone service that may result in a winner or alternative not receiving notification.

If Winner fails to provide any of these documents within the time allotted for any reason, Winner will be disqualified and forfeit the Prize, and Administrators may in their sole discretion and if time permits select and notify an alternate potential winner from among the remaining eligible Entries.

- c. **Release and Indemnification:** Entrant hereby releases, discharges, indemnifies, defends, and holds harmless Lincoln Valor LLC, Anheuser-Busch LLC, Lincoln Holdings LLC dba Monumental Sports & Entertainment, Anacostia Sports LLC, Lincoln GP LLC, Washington Sports & Entertainment LP, Washington Sports & Entertainment Inc., Washington Sports LLC, Washington Sports GP LLC, DC Arena LP dba Capital One Arena, Washington Bullets LP dba Washington Wizards, AP Tickets Inc., Centre Group LP, Monumental Ticketing LP, Lincoln Hockey LLC, Lincoln Mystics LLC, Lincoln Ballston LLC, Lincoln Ventures LLC, Arena Football League and its teams, Capital One, and advertising agencies and other persons and entities connected with the production, administration, judging, promotion, performance, distribution, or merchandising of the Sweepstakes, and all of their respective parents, subsidiaries, affiliates, licensees, successors in interest, members, partners, officers, directors, operators, agents and employees ("Released Parties") from and against any and all liability, damage, claim, demand, cost, expense (including attorneys' fees), or any injury, loss, or damage of any kind to persons including death or to property including but not limited to claims of copyright infringement, false endorsement, portrayal in a false light, violation of rights of privacy or publicity, or defamation, including those unknown or unsuspected by you at this time, arising out of or in any way resulting from or related to, in whole or in part, directly or indirectly, (i) entry, participation, or inability to participate in the Sweepstakes or any activity related to the Sweepstakes or any Prize; (ii) acceptance, possession, receipt, use, or misuse of any Prize or any component thereof; (iii) an Entry submitted by Entrant, including without limitation any allegation that Entry infringes, misappropriates, or otherwise violates intellectual property or any other proprietary right and/or any privacy, publicity, or any other personal right of Entrant or any third party; (iv) any violation by Entrant of the Official Rules; (iv) any statement, action, or failure to act by Entrant during or in connection with Entrant's participation in the Sweepstakes; (v) any breach or alleged breach by Entrant of the representations and warranties made herein; and (vi) any violation of law, regulation, or ordinance.

18. **SPONSOR'S TRADEMARKS:** BUDWEISER and BUD LIGHT are trademarks of Anheuser-Busch LLC, and WASHINGTON VALOR, and the WASHINGTON VALOR Eagle Logo are trademarks of Anacostia Sports LLC, and are not to be used without the prior written approval of the respective owner for any purpose other than entering the Sweepstakes.
19. **DISQUALIFICATION:** Any person may be disqualified from the Sweepstakes if Administrators in their sole discretion determine that person has done any of the following: (i) failed to satisfy the requirements for eligibility; provided Administrators with untruthful, inaccurate, or misleading information; (ii) used robotic, macro, automatic,

programmed or like methods to enter the Sweepstakes; (iii) violated any provision of the Official Rules; (iv) abused, tampered, or interfered in any manner with the Sweepstakes or the Sweepstakes Website; (v) acted in an unreasonable, non-sportsmanlike way; (vi) acted in any manner to annoy, abuse, threaten or harass any other person; (vii) given or agreed to give anything of value to any person associated in any manner with any Sponsor or any representative of any advertising agency, television network, television station, or other media to advance in the Sweepstakes or win any Prize; (viii) accepted or agreed to accept anything of value from any person to promote any product, service, or venture during the course of the Sweepstakes; (ix) posted and/or attempted to post one or more Fan Selfies containing Prohibited Contest as set forth in Rule 9.

RIGHT TO CANCEL OR MODIFY: Administrators reserve the right in their sole discretion to modify these Official Rules or to cancel, terminate, modify, suspend, or change any dates in the Sweepstakes for any reason or for no reason in their sole discretion. Possible reasons include but are not limited to ineligibility of Entrants, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes which, in the sole discretion of Administrators, corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes. If Administrators decide to reconvene the Sweepstakes after a suspension, the determination of prize winner(s) will be made from among all eligible, valid, non-suspect entries received as of the date of the suspension, or otherwise as may be deemed fair and equitable, in the sole discretion of Administrators. In the event that any legal or regulatory authority challenges the Sweepstakes, Administrators reserve the right to discontinue or modify the Sweepstakes, or to disqualify entrants residing in the affected geographic areas, and in such event, the Released Parties shall have no liability to any entrants who are disqualified due to such an action.
